#### **Executive Summary**

In the second quarter, regional launching of CBA Project continued. Launching of Project in 8 regions took place during the quarter along with dissemination of information on CBA approach, selection or rayons and establishing partnership with them. In total, 72 rayons and a city council were selected from 9 oblasts. Following to rayon selection, selection of village/city councils in the selected rayons commenced. 35 village councils were selected in 7 rayons of one oblast.

Selection of Project staffs as well as establishment of Project Management Unit (PMU) and Oblast Implementation Units (OIUs) continued during the quarter. Four staffs were selected/recruited for PMU and 16 staffs were selected/recruited for OIUs. With additional staffs, equipments and furniture, establishment of PMU got completed whereas establishment of additional 10 OIUs became possible. In toal, 19 OIUs (of 25 required) were established by 2<sup>nd</sup> guarter.

Training was conducted during the quarter to build capacity of project staffs. In total, 11 CBA staff and 9 staffs from national counterparts (oblast state administration) were trained. The participants received inhouse training and exposure visits to successful sites on community based approach to local development.

Other project activities during the quarter included (a) signing of partnership agreement with Ministry of Housing and Municipal Economy; (b) signing partnership agreement with 8 oblast authorities and 37 rayon authorities (c) initiating process for convening steering committee meeting; (d) carrying out PR, communication and visibility related activities such as press conferences, media events, media covereage, news letter; web site updating and guidelines preparation.

For the next quarter, selection of rayons and establishment of partnership is planned to continue. Selection of village/city councils will also continue. Local communities will be selected and community mobilisation process will be initiated. Establishment of OIUs will be accomplished in all oblasts with trained staffs, equipment and logistic arrangements. Also, CBA portal will be completed and various activities on PR and visibility will be undertaken.

#### 1.1 Project Genesis

#### 1.1.1 Background

Ukraine has made significant economic development since its independence. However, it is still challenged by some serious issues. Economic growth is not equitable, with only small share of population benefiting from its fruit. Those who suffer most live in rural and semi-urban areas. Low living standards in these areas are characterized, besides low income, by insufficient access to medical care and education, underdeveloped (or worn out) basic infrastructure and poor access to drinking water. Social, health and environmental problems at local level have is very common and warrant serious attention.

These challenges form a part of the MDG signed by Ukraine in 2000. To achieve these goals, much work is needed, especially at local level. The experience around the world<sup>1</sup> indicate that solution to these challenges is contingent on empowerment and active involvement of local communities, and their capacity to identify development priorities and ensure their attainment. However, legacy of the highly centralised system of policy, planning, budgeting and decision-making is yet to be adequately geared towards accommodating the needs and priorities as perceived by citizens and local authorities. On the other hand, passive attitude of the population in general and limited capacity of the local governments in rural areas to generate revenue remains a challenge.

Experience of European Commission's projects on pilot models for sustainable regional and local development have indicated the need to emphasize 'bottom-up" approach in tackling social needs of the poor population. On the other hand, Area-Based Development (ABD) Approach promoted by UNDP Ukraine through its projects<sup>2</sup> has proven to be an effective way of achieving social goals in a decentralised manner. In close partnership with local authorities and local communities, ABD Approach unleashes the potential of the people to help themselves. It brings local authorities and communities together for joint problem-solving and development activities, thus reinforcing the MDGs.

Joint EC-UNDP initiative - the Community-Based Approach to Local Development (CBA) is founded on the achievements of ABD approach and is meant for applying its main tenets country-wide and provide valuable inputs for the ongoing policy debate on administrative and fiscal decentralisation and further democratisation of society. CBA Project was launched in September 2007 and functioning since January 2008.

#### 1.1.2 Objectives

**Main objective** of the CBA Project is to create enabling environment for long-term self-sustaining social-economic and environmental development at local level throughout Ukraine.

#### **Specific objectives** of the Project are to:

- Improve living conditions in rural and (semi-) urban communities through sustainable communitybased self-help initiatives;
- Demonstrate participatory local governance, joint decision making and public private partnership for decentralised public service delivery through self-governing community organisations;
- Enhance professional skills and knowledge of community organizations and local authorities to initiate and maintain participatory local process on sustainable social economic development and public services delivery;
- Document experience on participatory planning, decision-making and social action with a view to providing inputs for policy and legal reforms.

#### 1.1.3 Project Strategy

The strategic goal of the CBA is to build capacity for participation of the local communities and local authorities into joint decision making process and use this capacity for multi-stakeholders cooperation and multi-sectoral interventions that are geared towards strengthening of local governance and sustainable human development with ensured local ownership of the process. To this end, following strategies are followed to materialise the objectives of the Programme.

All oblasts of Ukraine and in Autonomous Republic of Crimea form the overall project area of CBA while selected raiyons, village/city councils and local communities form the functional area. Selection is based on the level of socio-economic hardship facing them. Partnership, based on willingness and commitment for cost sharing, form the basis of Project implementation in the selected area.

ABD approach is utilized to unleash the potentials of selected communities to address their common needs focused around health, environment, energy, water supply and local transportation. To this end, the selected communities are organised into 'community organisation (CO)' founded on norms of good governance.

Appropriate support structures are created at various levels to facilitate smooth implementation of the Project. Through networking of local communities, local/regional authorities, private sector and civil societies appropriate for aare established at rayon/oblast level so that they can hold regular dialogue on sustainable development envisioning, mainstreaming of community plans, deciding upon public-private partnership mechanism for implementation of local priorities and carrying out participatory monitoring. Networking of stakeholders at the national level enables overall monitoring and advisory support.

Capacity of duty-bearers in the local communities, local government as well as national level officials is complemented through capacity building activities. Capacity of the COs is built in such a way that they are able to make joint decision with local authorities, mobilize resources, implement local priorities and sustain the result. Capacity of the partners (VC/CC, raiyon/oblast etc.) is strengthened in terms of human resources to implement participatory approach propagated by the Project. Training, exposure visits, dialogues and small grants (for community projects), appropriate instituional mechanisms etc. are used as tools for building capacity.

Appropriate management and information systems (MIS) is established to make the stakeholders directly involved in the process of monitoring and assessment of the Project activities. It includes process monitoring, input monitoring, output monitoring and impact monitoring. Flow of information is bottom-up and participatory.


Sustainability of the systems, institutions (community organizations etc.) and services established at local community level under support of the Project is ensured so as not to loose the principles and value propagated by the Project.

#### 1.2 Project Area

CBA Project will work in all oblasts of Ukraine and Autonomous Republic of Crimea covering total of 200 raiyons (eight in every oblast in average) and 1000 village/city councils (five in every raiyon in average).

In the second quarter, the Project launched its activities in 8 oblasts by holding regional seminars were held. 8 Partnership Agreements were signed with leadership of oblast administrations and councils. Selection of target rayons was held for 9 oblasts and 1 city council thus reaching 72 rayons and 1 city council during the quarter.

In total, CBA Project has been launched in 22 oblasts as of the  $2^{nd}$  quarter with partnership agreement signed with 16 oblast authorities (map – I below).

#### 2.1 Expected Results and Achievement

CBA-activities focused on establishing partnership with oblast authorities; During the quarter, establishing oblast implementation units (OIUs); selection of rayons and launching activities in the selected rayons. By June 2008, partnership agreement was signed with 16 oblast authorities, OIU was established in 19 oblasts, CBA was initiated in 73 rayons of which 35 village/city councils were selected for further action (details given in Table - I).

Deviation in terms of time and quantity of planned activities/targets occurred due to various factors as described, in brief, below:

- PMU began functioning only from January 2008, due to delay in getting competent staffs<sup>7</sup> on board. This delay met into delay in regional seminars and other Project activities;
- Launching of the Project in the regions was delayed due to slow response and changing priorities of the oblast authorities in some regions (specially in the east and the south) of the country;
- Further, signing of Partnership Agreements with the oblast authorities got delayed due to Internal procedures of draft review; time taken in getting concurrence on the draft from the Ministry of Foreign Affairs and change in oblast leadership;
- Delay in partnership with oblast authorities caused delay in establishment of oblast implementation units. Difficulty in getting competent staffs for OIUs further added to this delay;
- Delay in partnership with oblast authorities caused delay in selection of rayons and that of village/city councils.

In the above situation, the Project is undertaking multi-efforts to make full achievement of the tasks setforth for the first year of the Project. Nevertheless, a revisit of the targets may be necessary at appropriate point of time.

#### 2.2 Project Activities and Outputs

Among the activities planned for the 2<sup>nd</sup> quarter 2008 were launching of the Project in the regions; selection of rayons and village/city councils; establishing partnership with oblast and rayon level authorities; and promoting visibility. Details on these aspects are given hereunder.

#### 2.2.1 Establishment of partnership with oblasts and ARC

Achievement of sustainable development at local level relies on the partnership between governmental and non-governmental actors<sup>8</sup>. Therefore, establishment of formal partnership with oblast level authorities, through signing of partnership agreement, is considered to be a milestone in CBA implementation. Such agreements are also essential to formalize the role and commitment of the partners (local authorities and UNDP) and to provide an official basis to work with community organizations.

#### a) Holding Regional Seminars for presentation of CBA Project

In the reported period, 8 Regional Seminars were held in Vinnytska, Kyivska, Mykolaivska, Volynska, Chernihivska, Khersonska, Kharkivska oblasts and Autonomous Republic of Crimea.

The seminars were hosted by Heads/Deputy Heads of Oblast State Administrations and Councils. Participants of the seminars included oblasts' and rayons' authorities including heads/deputy heads of OSAs, OCs, RSAs, RCs; representatives of NGOs and mass media and in some cases the heads/deputy heads of village/city councils. In total, 494 persons attended the seminars during the quarter. During the seminars, heads of oblast authorities took the opportunity to publicly express their support for CBA Project (Box – I) and encouraged rayons to apply.

Meetings with oblast authorities were organized in the framework of each regional visit. At these meetings, representatives of oblast authorities (OSA and OC head/deputy head) assured Project Manager of their support for the CBA Project. Also, propositions of the authorities to the draft Partnership Agreement were discussed. Conclusions of the discussions were incorporated in the Agreement as necessary.

Total number of regions involved in CBA Project reached 22 (Annex - 1) by June 2008. About 1494 officials of local/regional authorities, civil society organisations and media people attended these seminars.

#### b) Signing of Partnership Agreements with oblast authorities

In the second quarter, 8 Partnership Agreements were signed by authorities of Vinnytska, Kyivska, Volynska, Chernihivska, Khersonska, Khmelnytska, Zakarpatska and Chernivetska oblasts. By 2<sup>nd</sup> quarter, total number of partnerships established with oblast authorities reached 16.

Signing Partnership Agreement was not specified as a precondition for launching Project activities in the region. Where signing did not take place, Regional Seminars were held and call for rayons' participation was announced. This was the case for Mykolaivska, Khersonska oblasts and ARC. In these regions, during personal meetings, oblast authorities expressed their determination to sign Partnership Agreement at a later date.

Regional launching of Project is expected to be completed by August 2008. Taking into account the delays related to approval of Partnership Agreements by oblasts, establishment of formal partnerships is expected to be finalized by September 2008.

#### **Box I. Opinion of Stakeholders About CBA**

It is not the finance offered by the Project that matters but its support for strengthening self-governance that enables communities to solve their problems has more value. The CBA Project will help us re-discover ourselves. It has offered equal opportunity for all rayons through competition-based participation.

Oleksandr Belskyi, Deputy Head of Chernihiv OSA

It's a substantial amount of money for village communities. What is good is that the spheres in which money will be invested are diverse: it can be used for procurement of medical equipment, school buses, introduction of energy-saving technologies etc.

Valeriy Asadchev, Head of Poltava Oblast State Administration

There is a range of pertinent issues in our oblast which cannot be solved without community participation. Community is very crucial part of local development. If we try to solve local problems through community, we can achieve much more than trying it through the state budget only. There are many good models of local development in European countries; it is good for us that CBA brings such an exemplary model. Let us use this Project to learn more and solve more problems. We do not need to wait for long for the system to get our problems solved. Real power and resources has to be given to local self-government bodies. CBA Project will greatly contribute to this process.

During the time of CIDP activities in the Autonomous Republic of Crimea, its citizens learnt what self-organization means and realized their involvement in the betterment of their region. It is very important to continue that practice so that it becomes a tradition. CBA will contribute to this end.

We are particularly pleased to know that the rayons that were selected for participation in CBA Project are located far away from Kyiv. These are the rayons which really need support, and we are very thankful to you to have sensed so accurately the problems of our region.

Financing given by the Project will surely not solve all the problems we have in the rayons, but our cooperation can prove the efficiency of the model proposed by international community and will change public opinion in favour of European integration of Ukraine.

#### 2.2.2 Establishment of partnership with pilot rayons/municipalities

Establishment of formal partnership with rayon authorities, through signing of partnership agreement, is considered to be second milestone in CBA implementation. It ensures clear role and commitment of the rayon authorities and provides an official basis to reach village/city councils. To this end, following steps were followed during the guarter:

#### a) Announcement of call for participation

In the reported period, announcement was made in 8 oblasts, during each regional seminar, for rayon authorities to send application forms to CBA office within 3 weeks. This announcement was for ensuring the principle of competition and transparency. In total, such announcements were made in 22 seminars since beginning of 2008.

#### b) Receiving and analyzing applications

As a follow up action to the announcement, the interested rayon authorities sent their application to the CBA office. The applications included information on social/economic/environmental hardship (access to water supply, access to medical services, environment situation, energy saving, school transportation) facing the rayon and leve of commitment expressed by the rayon authority. During the 2<sup>nd</sup> quarter, 211 rayons of 20 oblasts applied for participation in CBA Project. Total number of applications from 23 oblast amounts to 305, as given in Table – II (details in Annex - 2).

Besides collecting data from the rayons, information was also secured from the oblast state administration offices on ranking of rayons in their oblasts using 'social economic' data collected and updated by each OSA.

Received rayon applications were reviewed and analyzed by CBA Project in light of the information received from the rayon and oblast authorities and rayons of each oblast were ranked according to the hardship facing them.

#### c) Selecting pilot rayons

Selection of the pilot rayons were done by Rayon Selection Committee consisting of representatives from Oblast State Administration, Oblast Council, UNDP and CBA Project. During the quarter, meetings of Rayon Selection Committee were held for 9 oblasts (Chernihivska, Ivano-Frankivska, Kyivska, Luhanska, Rivnenska, Sumska, Ternopilska, Vinnytska, and Zhytomyrska). Under the leadership of UNDP Senior Programme Manager, Ms Oksana Remiga, the Committees reviewed the analysis of rayon applications and ranking of the rayons (done by CBA Project based on socio-economic hardship and commitment), discussed on the relative situation of the rayons and selected 8 rayons (in each oblast) or CBA Project along with alternatives.

In total, 72 rayons and 1 city council were selected for participation in CBA Project during the quarter, as shown in Annex - 3.

#### d) Announcement of selection results

In order to increase transparency and inform stakeholders and public about results of rayons selection, regional press conferences were organized in oblast state administrations in participation of representatives of OSA/OC. Typical agenda of press conference were:

#### e) Holding rayon seminars and signing partnership agreements

During the quarter, rayon seminars were held in 37 rayons of 6 oblasts: Chernihivska, Ivano-Frankivska, Luhanska, Rivnenska, Sumska and Zhytomyrska. They were attended by 930 persons, including heads of RSAs and RCs; heads of village/city councils; heads of relevant departments of RSAs and RCs. 49 media representatives attended the events. In course of the seminar, 37 tripartite Partnership Agreements with rayon authorities were signed. Partnership Agreements with 8 rayons and 1 town of Kyivska oblast were signed on 24 June after signing of PA with OSA. Total amount of PA with rayon/city authorities equals 46.

During rayon seminars, issues were raised by the participants on various aspects of the Project including mechanism of the Project implementation, partnership, community selection procedure, financing, methods etc. The Project team clarified the issues with support from rayin and oblast representatives. Some of the frequently asked questions with answers are given in Box - II:

Officials of the OSAs and OCs were key speakers during the seminars along with the CDAs and CDS of PMU, who prersented the CBA project to the participants. Ownership showed by the oblast authorities in reaching rayons is expected to have strong positive effect on the result of the Project. Participation on CDS was mainly

limited to initial backstopping, upon which the CDAs and oblast teams were able to continue with rayon seminars on their own.

Details on Rayon Seminars are given in Annex - 5.

#### **Box - II: Frequently Asked Questions During Rayon Seminars**

#### Q - What is the benefit for the UNDP to support Ukrainian village?

A - One of the mandates of UNDP is to assist countries across the world in reducing poverty and make the living condition of the people better. Ukraine is also facing poverty problem and living condition of the people has declined due to poor delivery of basic public services, which occur often due to broken or inefficient communal infrstructures. Poverty level in many Ukrainian villages is critical, and there are crucial social problems to be solved. Therefore, UNDP in Ukraine assists the Government, local

authorities and local communities in addressing these problems. It does so through development projects such as the CBA Project. It does fulfill its obligations as per the instructions and resources provided by its governing body. Its resources are used as a grant without room for direct or indirect return. Therefore, it does not seek any benefit or profit from its clients or target beneficiaires..

- Q Why the people should trust the Project and make financial contribution? Who will collect the resources? Who is responsible for spending it?
- A Approach of the CBA Project to work in partnership with local communities, local authorities and other stakeholders is founded on such elements as transparency, accountability and partnership. Partnreship is based on mutual trust. The Project trusts on good judgement of its local partners to select local priorities to be implemented through cost sharing. The Project contributes its share for the implementation of the community projects as is done by other partners, including the beneficiary communities. It is the beneficiary community which is responsible to collect and spend the money accummulated from various sources. For this purpose, the community members form a legal organisation, open bank account and maintain a transparent accounting system. CBA Project transfers its share into account of the community organisation and expects that the community organisation uses the resources based on UNDP financial rules. The Project provides necessary training to the community organisation so that it is able to accomplish the task with high degree of transparently and accountability. In this whole process, the Project trusts its local partners and in lieu expects to be trusted.

#### Q – What should be the legal form of the community organisation?

- A A community organisation can be registered under any of the available legal provision in the country. It is up to the decision of the community members. Each legal form has its own strengths and weaknesses. The best legal form is the one which allows the organisation to receive grant from the Project and other sources; allows to use this money under decision of the community members; allows the community organisation to transfer the property to concerned authority or retain on its own inventory; allows the organisation to raise users' fee from its beneficiary members and maintain the system created/rehabilitated under Project's support.
- Q Can one community make more than 1 project proposal?
- **A –** Yes, but the CBA's share is 10 000 \$ maximum for one project. This amount cannot be increased even if the community brings forth more than one proposal .
- Q Does the 5% share of the community include cost of project design estimates?
- A Yes.
- Q Is the cost sharing uniformly applicable to all level of local authorites i.e. should the local budget give 45% of micro-project drawing 20% from oblast budget, 20% from rayon and 5% from village/ town council, for example?
- **A -** No, it's not uniform. The proportion of cost sharing may differ depending on the availability of the budget with the particular level of authority for the purpose of the micro project identified by the community. It may also differ based on the mutual agreement/understanding among the partners.
- Q Some micro-projects are specific, for example, school bus purchase and maintenance. How will it come to the book of the entity of community organization? Is it acceptable in this case to transfer the transport facility to the book of the budget organization, e.g. rayon education department, which will maintain and repair it?
- A Yes, it's possible to transfer a transport facility to the book of a budget organization, but the legal framework is to be provided by local and rayon authorities. What is essential that the benefiting community must take charge of maintaining the system.
- Q In case of inflation or rise in price what is the way out for the project?
- A After the micro-project budget is approved and financing agreement is signed, additional financing from the Project is not impossible. To mimimise the problems due to inflation, it is recommended to (a) incorporate such risks during the stage of proposal prepration/project planning; (b) avoid delay of implementation.

#### Q - If the community covers several priority areas of the Project is there more chance to succeed?

A – Even if the community might be facing several development challenges, it should not try to address all of them at the same time through community projects. It will be difficult as the people will get tired of making financial and non-financial contributions for all of them. Moreover, each project will demand various administrative/financial precisions and may create conflict. Therefore, it is advisable to undetake priorities one by one even if there is a chance to succeed.

#### Q - Is the number of participants of community organisation regulated?

A – In principle, self-organization process should cover not less than 80% of households located on the territory in question. This territory may be a village or a group of villages in vicinity; houses along a street or apartments in a multi-storyed building and so on. From the perspective of viability participation of only a few households is not appropriate. Similarly, a large number of houselhod participation is not appropriate from the perspective of mutual interaction and consensus based decision-making. Therefore, a community organisation with 40-80 members is considered appropriate. If there are more people willing, it's recommended to set up more organizations and unite them into an association. Similarly, a smaller communities located in the vicinity could join together to form a bigger organisation.

#### Q - Will other communities/village councils have the opportunity to participate in CBA Project?

**A –** In the present scenario, we work with only five village/town councils in a rayon. In case there is high degree of success from the present partnership and if additional funding is available from the donors then it might be possible to add more village/city councils in future.

### 2.2.3 Establishing partnership with village / city councils

Establishing partnership with local councils is considered to be third milestone in CBA implementation at local level. It ensures commitment of the village/city councils to support participatory approach to local sustainable development and provides official basis to reach local communities. To this end, following steps were followed during the quarter:

#### a) Annoucement of call for participation

Announcement was made during each rayon seminar for the village/city councils in the rayon to send application to the oblast community resource centre explaining their

situations in terms of hardship on access to water supply, access to medical services, environment situation, energy saving and school transportation. They were also expected to express their commitment in terms of making financial and non-financial support. In general, one week was set as a time for making such application. access to water, facing them in within a week of date of announcement.

#### b) Receiving of application and analysing of information

During the quarter, 106 applications were received from village/city councils of 7 rayons of Zhytomyrska oblast. The team of the oblast community resource centre analysed the information of the applications and information received from the respective rayon state administrations. Based on the analysis, they made a ranking of the participating local councils based on the level of hardship facing them. The analysis and ranking was further reviewed by related specialists of the PMU.

#### c) Selection of village/city councils

Meeting of the Village/city council Selection Committee in Zhytomyrska oblast was held for 7 rayons to make selection of 5 village/city council for CBA project. In all cases, the Meeting was presided by CBA focal point of Oblast State Admistration. Other participants of the Meeting included representatives from Oblast Council, Rayon State Administrations, Rayon Councils, and CDAs of the OIU Project in the oblast. The Committee reviewed the analysis of Village/city council applications; ranked them based on socio-economic hardship and commitment and selected 5 Village/city council for CBA project with alternatives.

In total, 35 village councils (VCs) from 7 rayons were selected as shown in Table - IV.

#### 2.3.4. Capacity Building: Training of CBA project staff and national counterparts

During the quarter, 1 training was organized for 11 CDAs (6 males, 5 females) from 8 oblasts and 9 employees of oblast state administrations (3 males and 6 females). The training was accomplished in three events: pre-job training (for potential CDAs); on-the job training for selected CDAs and deputed officials from OSAs and exposure visit.

Hosted by Rivne oblast state administration and Rivne CRC, the training was supported by MGSDP and CRDP. The training was initiated by first deputy head of Rivne OSA, Mr. Stepan Pavliuk. In his opening remarks Mr. Pavliuk opined that the Project particularly valuable because of its community-oriented approach and assured the Administrations' support for the initiative.

In course of the training, the participants were exposed to theoretical framework and implementation procedures of CBA approach. They were also exposed to field realities in the CRDP and MGSDP field areas. A summary of the training course is given in Box - III and details are given in Annex - 6.

The result obtained is twofold: firstly, the training deepened understanding of CBA approach and objectives among the participants; secondly, it created strong teambuilding and mutual cooperation

among the CRC-teams which consist project staffs as well as officials of OSAs deputed to CRC. In course of training, Mr. Ihor Tymoshenko, head of economic department of Rivne oblast state administration opined the CBA project is outstanding among other initiatives, and will be supported and facilitated by oblast administration.

Since beginning of 2008, 8 training courses were organised by the Project to train 57 potential candidates, 22 project staffs and 18 officials from counterpart agencies (oblast state administrations) were trained (Table - VI).

During the concluding session of the training, the participants explicitly expressed their opinion about relevance and effectiveness of the training. Their overall impression was that the training provided them adequate theoretical and practical exposure on the subject of community based local development in various socio-economic situation in Ukraine. Besides, it expanded horizon of their knowledge and confidence to mobilize stakeholders and get the participatory approach translated into action. Some of their impressions are mentioned in Box - IV.

#### 2.3.5. Communication and visibility

Communication and PR activities are designed as a part of Project implementation strategy. In the second quarter, regional/local authorities and media the major target groups of CBA communication activities. Wider public and potential participants were familiarized with Project activities and plans through local media and CBA web site. Visibility of EU and UNDP was assured by each of communication activities.

#### a) Media events

48 media events were organised, among them are 8 Regional Seminars, 34 Rayon Seminars and 6 press conferences for announcement of results of rayon selection. Information packs containing CBA brochures, notepads, pens and printouts of presentation were distributed during each of the event. Media activities are described in details hereunder:

Regional Seminars were organized as media events and attended by approximately 494 participants, including senior management of OSAs and OCs, RSAs and RCs, representatives of local NGOs and mass media. Each media

event was announced through media advisories distributed to local media through OSA Press Services. During the event, press releases were distributed containing more detailed information on the CBA Project and its further activities in the region. Both EU and UNDP logos were visually

represented at the press. About 40 representatives of local media participated.

Regional press conferences were organised with support from oblast state administrations as envisaged in the 'communication action plan' for making announcement of rayons selected for participation in CBA Project. Underlying was the idea of assuring maximum transparency of the procedure of rayon selection process. A total of 58 media persons attended these conferences.

<u>Rayon Seminars</u> were held to launch CBA activities in pilot rayons and sign Partnership Agreements with local authorities. To each of the events, representatives of local media were invited, information packs were

distributed. In 34 rayon seminars held, 930 officials and 49 media representatives participated.

By 2<sup>nd</sup> quarter, a total of 62 media events took place through 22 regional seminars, 34 rayons seminars and 6 regional press conferences (Table - VIII).

#### b) Media coverage

#### c) Consultations on Communication Strategy and Visibility Guidelines

Communication Strategy and Action Plan were amended and are currently under review of senior management and EU/UNDP Communications Officers. Visibility Guidelines were amended (Annex – 7) so as to suit best the need of Oblast Implementation Units, and submitted for review of senior management.

#### d) Dissemination of Information about CBA

In order to distribute information about the Project among stakeholders, potential participants and wider public, following actions were undertaken:

- Newsletter was issued featuring news about CBA implementation as of May 2008;
- News about CBA implementation were regularly published on CBA web site
- Information about CBA activities and implementation progress was sent to Project on Information and PR Activities for the EU and its Programmes in Ukraine, which were then published in EC Cooperation Newsletter (see section 2.3.5 (2).
- Leaflet of CBA was drafted and distributed during media events.
- UNDP's documentary film "One Step Ahead: How Ukrainian Communities Are Helping Themselves" was re-produced and disseminated among target audience, namely, representatives of oblast and rayons' authorities. The film intends to (1) familiarize local stakeholders and communities with the essence of the CBA approach, (2) give example of communities' and local authorities' proactiveness, to be followed within the frametork of CBA implementation.

f) **Visibility tools** such as banners, sets of big and small flags of EU, UN and Ukraine, information stands, office signboards, were produced and distributed among OIUs as specified in Annex - 8.

#### g) Development of web portal

Draft structural and functional scheme of web site database of micro-projects, participants, partners and documents was developed by contractor in close cooperation and consultations with PMU.

#### 2.3.6. Establishment of Project Management Unit (PMU)

In the reported period, recruitment process continued to complete the PMU team. With addition of two engineers, an IT specialist and a driver during the quarter, number of personnel at PMU reached 11 of 12 required. Similarly, most of the needed equipment were either procured or were put into process of procurement. Annex - 9 contains list of the PMU team.

#### 2.3.7. Establishment of Oblast Implementation Units/ Community Resource Centres

#### a) OIU staff selection

Process continued during the quarter for recruitment of CDAs and drivers for OIUs. Applications received upon vacancy announcements made widely at national as well as local level, were analysed and potential candidated shortlisted. Shortlisted CDA-candidates were provided with training and written tests before interview. A total of 27 CDAs and 7 drivers were selected and/or recruited. By end June 2008, 27 CDAs (of required 48) were recruited to serve 18 oblasts + ARC. Also, 7 drivers (of required 24) were selected and/or recruited. Details are given in Annex – 9.

Difficulty was faced with getting competent candidates from the oblasts because of the following reasons:

- High opportunity for the competent and experiened people exisit in the oblasts. As a result, they
  are often engaged and do not want to change the job;
- Labour market is competitive and the Project is not able to compete in terms of incentive package

#### b) Establishment of OIU

During this quarter, 12 OIUs were allocated premises (including Kyiv office located in PMU and Crimean office embedded in CIDP) by the partner OSAs/OCs. Procurement of furniture and equipment was completed for 4 OIUs: Lunansk, Rivne, Zhytomyr, Kyiv.

As of 2<sup>nd</sup> quarter, furniture were made available to 7 OIUs, equipments were made available to 10 OIUs and 7 OIUs had received communication facility (telephone, internet etc.) from OSAs.

Details are given in Annex - 10.

#### 2.3.8 Advisory and management

Activities related with financial dimension, advisory support, monitoring and resource mobilisation etc. took place during the quarter as described hereunder in detail:

#### a) Financial delivery

Gross *delivery* of US \$ 920,534 (638'850 Euros) was made since the beginning of the year (including \$ 54,211 (37'622 Euros) actual disbursement in 1<sup>st</sup> Quarter, \$ 226,248 (157'016 Euros) actual disbursement in  $2^{nd}$  Quarter and \$ 640,075 (444'212 Euros) worth of commitment (request was made for procurement of equipments, furniture and vehicles etc.). Activity-wise delivery is given in Table – XII.

In total, 56% delivery was achieved by June 2008. Low delivery was seen in case of some activities which are yet to come in the process. They are -

- CO formation (will take place in Q3 and Q4) upon selection of local communities;
- Training of CO-members (will take place in Q3 and Q4, upon formation of COs);
- Training of officials of local authorities (planned for Q3);
- CO planning and integration (will occur in Q3 and Q4, upon training of COs is over);
- Partnership with rayon authorities and village/city councils (will continue in Q3 and Q4).

#### b) Operational manual

Second draft of CBA Operational Manual was reviewed and translated.

#### c) Partnership with national agencies

On 10 June Memorandum of Understanding was signed between Ministry of Housing and Municipal Economy of Ukraine and UNDP in Ukraine. According to the Memorandum, UNDP and the Ministry will cooperate for reformation and sustainable development of municipal and housing economy, elaborating the national benchmarks in the area, and collecting and promoting the best practices of public services delivery to residents (through policy and legislation reforms, scientific research, communication activities). Special attention will be paid to joint efforts in the area of environment and energy efficiency (e.g. introduction of the energy efficient mechanisms in communal services; realizing initiatives on improvement of the outdated drainage, sewage systems and solid waste management). The focus of the efforts will be made on promoting creation and support to the

activities of condominium associations and creation of competitive market of communal services, for which the capacity of both communities and local authorities will be built to ensure the quality service delivery.

#### d) Steering committee meeting

Preparation for convening steering committee meeting was initiated. In this regard, (a) letters to ministries, parliamentary committees and other relevant national agencies were drafted and approved; (b) list of invitees was approved; (c) terms of reference for steering committee was drafted and sent for approval to Department of Regional Development, Secretariat of the Cabinet of Ministers of Ukraine.

#### e) Review Meeting

Review meeting on progress of Project implementation took place on 11 July in participation of EC Project Manager Volodymyr Kondrachuk, UNDP Senior Program Manager Oksana Remiga and Project Management team. Key issues on the agenda included update on progress of CBA implementation, Project registration and organization of Steering Committee meeting, human resource Management, Visibility and PR. For details on discussion, please see Annex – 11.

#### f) Resource mobilisation and utilisation

#### 3.1 Stocking the Experience

Following lessons were learned during the quarter in course of CBA implementation:

- The involvment of oblast state administration and oblast council in rayon selection process has strengthened the transparency of selection procedure as well partnership with project.
- In rayon seminar, the participation of representatives of oblast state administration and oblast council has showed the ownership to the project. The project was well accepted and develop strong partnership with rayon authorities.
- Cost effective dissemination News in Obast website regarding selection on rayon, seminar in rayon, press conference by oblast authorites after rayon selection.
- A substantial amount of time had to be spent on logistical arrangements, organization of repair works, procurement of equipment etc at the level of OIUs. Factors hindering optimal speed of Project implementation in several regions, pointed out the were noted by CDAs as: (a) length of bureaucratic procedures of OSAs; (b) change of OSA leadership; (c) politization of local government; (d) misperception of the role of CDAs by OSA officials; (e) delay in office setup/equipment availability and telephone/internet connection.
- In several regions, success in forming the oblast implementation team was noted. Involvement of coordinators from OSAs was a positive factor for efficiency of the preparatory phase.

#### 3.2 Outlook for future

In line with the Annual Work Plan and in sequence of the activities being pursued, following activities are envisaged for the 3<sup>rd</sup> quarter:

- Completing regional seminars and establishing partnership with oblast authorities;
- Continuation of rayon selecction in the remaining oblasts and establishing partnership with the selected rayons;
- Continuation of holding rayon seminars; selection of Village/City Councils in the selected rayons and forging partnership with them;
- Initiating establishment and development of COs in selected VC/CC councils;
- Organising training for CO leaders and local authorities;
- · Recruitment of remaining staffs of OIUs and their training;
- Completion of OIU/CRCs establishment;
- Forging partnership with ministry of regional development and state construction
- Holding steering committee meeting;
- In Communication and Visibility:
  - Finalization of Communication Strategy and Action Plan.
  - Series of media events for announcement of results of rayons' selection;
  - Assuring appropriate EU/UNDP visibility in PMU and OIUs;
  - Strengthening of CBA portal
  - Establishment of functional databease of partners, participants, projects and documents on CBA web site;
  - Organising press conferences for announcement of results;

# Annex - 7 Visibility Guidelines for PMU and OIU staff of Community Based Approach to Local Development Project

#### **Summary**

The present Guidelines have been drawn up to ensure that CBA Project funded by the European Union (EU) and co-financed and implemented by United Nations Development Programme (UNDP) visibly and in appropriate manner acknowledges the support of both organizations. The guidelines cover the written and visual identity of the EU and UNDP (hereinafter "the Parties") and apply to print, electronic and any other material, presentation, banner, invitation, and other physical manifestations of relevant projects. The guidelines are intended to enable CBA staff a well as partner executing agencies to reflect the Parties' support in an appropriate manner.

#### 1. BACKGROUND

Accountability to contributors is one of the basic rules of any sound management of third parties' resources. The CBA Project operates with resources, 90% of which come from the EU Member States through the European Commission and 10% comes from UNDP. Thus EU and UNDP are entitled to receive appropriate recognition of their support to the Project through proper acknowledgement and visibility. One of the ways in which the Parties' contributions can be acknowledged is by visual acknowledgement of their support.

These guidelines are designed to ensure that actions of the CBA Project, funded by the European Union (EU) and co-financed and implemented by the United Nations Development Programme (UNDP), incorporate information and communication activities that will raise awareness of its target or general audiences in the regions and reflect impact of the EU-UNDP cooperation on life of the target population.

The guidelines cover the written and visual identity of the Parties and apply to printed, electronic and any other form of materials, presentation, banner, invitation and other physical manifestations of the CBA Project. The guidelines are intended to enable CBA staffs both in the central 'Project Management Unit' and in regional 'Oblast Implementation Units' to acknowledge the Parties' support and contributions in an appropriate manner.

Note that these guidelines are in consistent with "Communication and Visibility Manual for EU External Actions" of the European Commission.

#### 2. EXISTING FRAMEWORK OF COOPERATION

The current framework of cooperation between the EC and the UN in relation to visibility is defined in the following documents:

- Article 11 of Financial and Administrative Framework Agreement between the European Commission and the United Nations. (29 April 2003);
- Article 6 of General Conditions applicable to European Community contribution agreements with international organizations, Annex II to European Commission's Contribution Agreement with International organization (UN).
- Joint Visibility Guidelines for EC-UN Actions in the field;
- Joint Visibility Action Plan on Visibility signed on 22 September 2006.

According to Article 11 of the Financial and Administrative Framework Agreement and Article 6 of the General Conditions, UN Agencies as well as other partners should take all appropriate measures to publicize the fact that an Action has received funding from the European Union. Information given to the press and the beneficiaries of the Action through related publicity material, official notices, reports and publications, shall acknowledge that the Action was carried out "with funding by the European Union" and shall display in an appropriate way the European logo (please see Annex 1 for details).

#### 3. GENERAL PROVISIONS

The main objective of visibility clauses is the communication of the positive results of the partnership. In addition to inputs, visibility activities should focus on outputs and the impact of the action's results.

Visibility Activities need to take into account and reflect the multi-party nature of multi-donor agreements as they highlight the partnership with the EC.

The CBA staffs shall take all appropriate measures to ensure that the visibility provisions are duly respected and that their services comply with the visibility obligations.

The CBA staffs, in the framework of UNDP regular reporting requirements, will report on their assessment of the implementation of the visibility provisions.

The results of the reports on visibility will be discussed in the annual meetings of Senior Project Management group, including representatives of the Delegation of European Commission and UNDP. Specific recommendations to improve the implementation of such visibility provisions, as necessary, may be adopted during these meetings.

When the context and available resources permit, CBA staff should complement basic elements of static visibility and information communication with dynamic ways of highlighting EU's and UNDP's support, as well as the impact of the action.

All communication and visibility activities should be carried out in close co-operation between the CBA/PMU staff and the Delegation of the European Commission. Within CBA Project, it will be done in close cooperation between OIUs and CBA Communications Specialist.

#### 4. APPLYING VISIBILITY PROVISIONS IN CBA ACTIVITIES

#### 4.1 Equipping offices with visibility tools

Oblast Implementation Units/ Community Resource Centre as well as PMU shall be equipped with following items:

- (1) 1 set of big and 2 sets of small EU, UN and Ukraine's flags;
- (2) Signboard with EU and UNDP logos;
- (3) Information stand for display of printed materials and publications;
- (4) Information board for display of photos, announcements etc.;
- (5) Banners (1 vertical and 1 horizontal) intended to serve as a backdrop for special events such as inaugurations, conferences, trainings and seminars should also carry the EU and UNDP logo and, if pertinent, the full sentence "Project is funded by the European Union" "Project is and co-financed and implemented by UNDP".

#### 4.2 Stationery

Letterheads or fax headers sheets used by PMU and OIUs must include both the EU logo with the sentence "Project is funded by the European Union" and UNDP logo with the sentence "Project is co-financed and implemented by UNDP". The official type font of the CBA Project is Arial, font size 11.

Template letterheads for PMU and OIUs are attached in Annexes 2 and 3.

#### 4.3 Events

For public and media events, invitations, panels stationery and information materials distributed during the event must bear the EU and UNDP logos, equal in size and prominence.

Depending on the circumstances, the opportunity should be taken to display during all public and media events:

- (1) banners with the EU and UNDP logos in meeting rooms;
- (2) EU, UN and Ukraine's flags.

Organization of media events at local level shall be done in consultation with CBA Communications Specialist. The EC counterpart should be duly informed and, if appropriate, invited to participate in public and media events of the CBA Project though PMU.

#### 4.4 Press Releases

The agreed template (Annex 4) should be used whenever a press release or media advisory is to be issued.

The release should incorporate the EU and UNDP logo, mention that the EU funds the Project, and the UNDP co-finances and implements it. The release should also mention the amount of EU funding.

If a press conference with the attendance of an EU personality is planned, his/her name must be mentioned in the release.

All regionally issued press releases should be agreed with CBA Communications Specialist. Press and Information Officer at the EC Delegation and Communications Officer of UNDP should be informed whenever a press release is issued at national level by PMU.

#### 4.5 Commemorative plagues

Permanent commemorative plaques are an effective way of acknowledging the involvement of Parties in the construction or reconstruction of permanent structures. As part of the opening ceremony (i.e. at the start of the community project implementation) of permanent structures to be erected within the framework of CBA acivities, a permanent plaque must be placed in the most visible part of the structure (e.g. at the main entrance or in front of the building – if the supported structure is an element of the building). UNDP logo should be positioned in the lower-right hand corner, and the EU logo should be in the lower-left hand corner. The plaque must contain the EU and UNDP logos and the following sentence: "This [name of the structure] was funded by the European Union and co-financed by UNDP, local budget of [name of] rayon / village council / city council and [name] community organization.

#### 4.6 Vehicles, Supply and Equipment

All CBA cars shall carry EU and UNDP stickers of the same size and prominence.

All items of furniture and equipment purchased for PMU or OIUs, should bear stickers prominently featuring EU and UNDP logos and the mention "Provided by European Union" in English and Ukrainian.

#### 4.7 Leaflets, Brochures and Newsletters

Publications such as leaflets brochures and newsletters can be useful in communicating the results of an action to specific audiences. They must be issued as specified in the Communication Action Plan.

- o Leaflets should provide basic factual information and the address (such as a mailing address or web site) where further information can be found;
- o Brochures can go into greater detail, highlighting the context, including interviews with stakeholders, beneficiaries, and so on;
- o Newsletters are characterised by their regularity, and can be issued to inform on the progress of an action. This is useful, for example for infrastructure projects, training programmes, and so on, where the impact of an action can be appreciated over time.

Publications should always be tailored to the audience in question, and focus on the intended results of the action, not the financial and administrative details. Texts should be short and simple, and photographs used where possible to illustrate the action and its context. If possible photographs should be of the people involved in the action, rather than the officials responsible for its management.

In general, all material produced in paper form should also be made available in electronic form, so that it can be sent by e-mail and posted on a web site. Depending on capacity of the OIU/PMU, budget availability and capacity of the target audience, newsletters may be distributed through appropriate mailing lists, and/or can be mailed in electronic form through e-mail distribution list and/or can be posted on web site. For material in paper form, distribution capacity (mailing lists) should be considered. Template for newsletter is attached in Annex 5.

All leaflets and brochures should incorporate the basic elements of EU and UNDP visual identity, i.e. the EU flag and UNDP logo, the disclaimer and project details, contact name, address, telephone, fax and e-mail details.

Leaflets and brochures must also incorporate a definition of the EU and UNDP as follows:

"The European Union is made up of 27 Member States who have decided to gradually link together their know-how, resources and destinies. Together, during a period of enlargement of 50 years, they have built a zone of stability, democracy and sustainable development whilst maintaining cultural diversity, tolerance and individual freedoms. The European Union is committed to sharing its achievements and its values with countries and peoples beyond its borders".

UNDP is the UN's global development network, advocating for change and connecting countries to knowledge, experience and resources to help people build a better life. We are on the ground in 166 countries, working with them on their own solutions to global and national development challenges. As they develop local capacity, they draw ont eh people of UNDP and our wide range of partners.

#### 4.8 Publications

Neither the European Commission nor its Delegation in Ukraine will be responsible for the contents of any written material prepared by UNDP and/or Implementing Partners. These must therefore include the following disclaimer in their written materials: "This publication has been produced with the assistance of the European Union. The content of this publication is the sole responsibility of <name of the author/executing agent/implementing partner>. This publication is not intended to create any obligations and does not express official position and/or views of the European Commission, donor countries' governments, UNDP or any other UN project or program". / «Дана публікація здійснена за допомоги Європейського союзу. Вона представляє погляди авторів та в жодному разі не є будь-яким зобов'язанням та не висловлює офіційну позицію та погляди Європейської Комісії, урядів країн-донорів, Програми розвитку ООН чи організацій та закладів системи ООН».

Design of all publications shall be agreed with Press and Information Officer at the EC Delegation and Communications Officer of UNDP..

#### 4.9 Promotional Items

Promotional items should be distributed when specified in the communication strategy. They can be produced as supporting material for CBA information and communication activities. Promotional items should contain EU and UNDP logos or a CBA logo.

Before taking any decision on production of such items, the Press and Information Officer at the EC Delegation and Communications Officer of UNDP should be consulted.

#### Annex -7A

#### Visual Identity Elements of EU and UNDP

The common element branding the EU and UNDP cooperation within the framework of CBA Project includes placement of logos of both organizations in equal proportion. Resizing of logos should be done proportionally. The EU logo should be placed at the top left-hand corner. UNDP logo should be placed at the top right-hand corner.

#### 1. Size, position and comparison to other logos

Whatever the size, scope or objectives of a project or activity, the EU and UNDP logos should be prominently displayed as specified in these guidelines on all materials produced by the executing agent and implementing partner(s).

#### 2. Backgrounds

The logos should preferably be printed on a white background. Multicolour backgrounds should be avoided, especially those involving a colour that clashes with the blue.

#### 3. Alterations and Additions

Agents and Partners should be aware that when reproducing the EU and the UNDP logos in graphic presentations they must be used in their entirety, without any alterations or additions. Other logos should be presented separately.

#### 4. EU logo as the common element branding an EU-funded Project




#### 4.1 Symbolic description

Against the background of blue sky, twelve golden stars form a circle, representing the union of the peoples of Europe. The number of stars is fixed, twelve being the symbol of perfection and unity.

#### 4.2 Heraldic description

On an azure field a circle of twelve golden mullets, their points not touching.

#### Geometric description



The emblem is in the form of a blue rectangular flag of which the fly is one and a half times the length of the hoist. Twelve gold stars situated at equal intervals form an invisible circle whose centre is the point of intersection of the diagonals of the rectangle. The radius of the circle is equal to one-third of the height of the hoist. Each of the stars has five points which are situated on the circumference of an invisible circle whose radius is equal to one-eighteenth of the height of the hoist. All the stars are upright - that is to say, with the one point vertical and two points in a straight line at right angles to the mast. The circle is arranged so that the stars appear in the

position of the hours on the face of a clock. Their number is invariable.

#### 4.4 Regulation colours

The emblem is in the following colours:

PANTONE REFLEX BLUE for the surface of the rectangle; PANTONE YELLOW for the stars. The international PANTONE range is very widely available and easily accessible even for non-professionals.

#### Four-colour process

If the four-colour process is used, it is not possible to use the two standard colours. It is therefore necessary

to recreate them by using the four colours of the four-colour process. The *PANTONE YELLOW* is obtained by using 100% "Process Yellow". By mixing 100% "Process Cyan" and 80% "Process Magenta" one can get a colour very similar to the *PANTONE REFLEX BLUE*.

#### Internet

PANTONE REFLEX BLUE corresponds in the web-palette colour RGB:0/51/153 (hexadecimal: 003399) and PANTONE YELLOW corresponds in the web-palette colour RGB:255/204/0 (hexadecimal: FFCC00).

#### 4.5 Monochrome reproduction process

If only black is available, outline the rectangle in black and print the stars in black and white.





In the event that blue is the only colour available (it must be Reflex Blue, of course), use it 100% with the stars reproduced in negative white and the field 100% blue.

#### 4.6 Reproduction on coloured background

The emblem is reproduced for preference on a white background. Avoid a background of varied colours, and in any case one which does not go with blue. If there should be no alternative to a coloured background, put a white border around the rectangle, with the width of this being equal to 1/25 of the height of the rectangle.



## Annex – 11 Minutes of CBA Management and Staff Meeting

11 June 2008, 14h30 – 16h30, Project Management Unit, Kyiv

Present: Volodymyr Kondrachuk, Oksana Remiga, Jaysingh Sah, Volodymyr Sheyhus, Yugesh Pradhanang, Ganna Yatsyuk, Kateryna Bazayants.

#### **CBA** Implementation

Dr.Sah briefed on progress of Project implementation and key activities planned for the period up August 2008 when the 1<sup>st</sup> year of Project implementation ends.

#### **Project registration**

Ms Remiga briefed on the status of Project registration.

#### **Steering Committee meeting**

Organization of the meeting was discussed, including potential participants from EC and UNDP sides, Conference hall of the Ministry of Housing was designated as one of the possible venues for holding the meeting.

#### **HR Management**

Taking into account the situation at local labour market, as well as high inflation rates in domestic economy, salaries of Community Development Assistants should be reviewed. Discussion of modification of salary rates is planned for end July – beginning August, so that request for modification could be included in the Annual Report.

An HR management strategy has to be put in place in order to preserve the human recourse which was retrieved and trained. Issue of notification of termination of contract was discussed, CDAs have to be asked to inform about their intention to quit well in advance, so that it does not create problems in Project implementation in the region.

**Financial delivery** was presented and discussed. At least 80% delivery is expected to be done by end August, including commitment. Samples of EU financial reporting were requested by CBA Financial Manager.

#### Visibility and PR

Ms Yatsyuk briefed on the status of visibility tools production and OIU equipment with visibility materials and presented current balance of expenditures for visibility tools. In this regard, following decisions were taken:

- (1) to give priority to producing pens and brochures for rayon seminars. Content of a brochure is to be revised and simplified.
- (2) production of banners, posters and CDs is to be completed be end June.
- (3) in view of the fact that major expenditures for visibility budget are to be done at the initial stage of OIU establishment, yearly limit of €15.000 can be exceeded, it should be reflected in the financial reporting.

Necessity of strengthening linkage with EU system of public information was discussed. In this regard, it was agreed that the news on CBA activities will be regularly sent to EC Cooperation Newsletter. Press releases about oblast-level events should be sent to EC Project Manager as well as EC Cooperation Newsletter either in advance of 1-2 days after the event.

Proposition was voiced to assure more transparency in rayons selection process by reflecting information about Rayon Selection Meetings on the CBA web site.

A meeting should be organized with EC Communications Officer Matthew Green to discuss CBA Communication Strategy and approve templates of letterheads and press releases.

Comments and propositions for improvement of Newsletter design and content were voiced and discussed.

Web portal development. Best use of modern Internet technologies is to be used to monitor Project implementation. In this regard, web portal of CBA is to be designed in such a way as to simplify collection of data from field and the system of alerts is to be designed in such a way as to inform Project Management team about all the events planned and held, as well as about deadlines.

#### **Outlook for the Future**

VK expressed his long-term plans of public events, namely (1) a Forum with Civil Society to discuss the Concept Paper of Involvement of NGOs in Project Implementation; (2) Presentation of CBA Project to donors and representatives of biggest EU Member States. Key objectives and Concept Notes of these 2 events are to be prepared.
